



A Letter from the Firm

- uninsured/underinsured coverage provides additional coverage to you if you are injured and the responsible person has lower limits,
- medical payment coverage reimburses you for medical bills.

As the cost of medical care continues to rise and as your personal assets increase, your limits should be adjusted upward to provide the additional necessary protection. I have included a sample declarations page on the inside back cover of this magazine so you can see how to review your automobile policy.
